

# Invitation for Bid (IFB-41)

## DEPARTMENT OF BUILDINGS, NORTHERN PROVINCE.

1. The **Chairman, Regional Procurement Committee**, on behalf of the Department of buildings, Northern Province, invites sealed bids from eligible and qualified bidders for the Construction work described in the table below.
2. Bidding will be conducted through **National Competitive Bidding**, however limited to the bidder who registered within the administrative boundary of the **Northern Province**.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered with the Construction Industry Development Authority (CIDA) in the field of building construction for grade mentioned in the table below.
4. Qualifications requirements are indicated in section 4 of the Bidding document. Additional details are provided in the **Schedule** (Section 5).

Bid number must be written on the left-hand upper corner of envelope. Late Bids will be rejected. Bids will be opened soon after closing in the presence of the Bidder's representatives who choose to attend.
