- iv. Candidate should have had at least three (03) years of continuous permanent residence in the Northern Province within the six years immediately prior to the date of closing of applications. (Voters list should be submitted to prove the permanent residence.)

WITH

A Postgraduate Degree qualification (Masters') in the relevant field or Associate Membership of a recognized professional Chartered Institute, which is relevant to the subject area of the post

AND

Minimum of 15 years' experience at a "Managerial Level" in a Corporation, Statutory Board/ Government Institution or a reputed private institution.

2. Full Membership of a recognized professional Chartered Institution in a related field to the post

AND

Minimum of 15 years' experience at a "Managerial Level" in Corporation, Statutory Board/ Government Institution or a reputed private institution

Age

Should not be less than 35 years and not more than 55 years of age

2. Assistant General Manager -Administration & Finance- Number of Post one

Qualifications & Experiences (1 or 2 or 3 below)

1. A Degree in a relevant field of Commerce / Business Administration / Management / Public Administration / Accountancy which is recognized by the U.G.C.

AND

A minimum of one-year post qualifying experience in the relevant field to the Post, after obtaining the first degree.

2. Having passed the Intermediate Examination of a recognized professional Chartered Institute, in the subject area of Accountancy which is relevant to the post and a minimum one-year post qualifying experience in the relevant field to the post.

3. Having obtained a Higher Diploma in Accountancy from the Sri Lanka Technical College or Sri Lanka Institute of Higher Technical Education.

A minimum of one-year post qualifying experience in Public Service, a Corporation, Statutory Board / Institution or a reputed Private Institution.

Qualifications & Experiences (1 or 2 or 3 or 4 below)

1. A Degree in a relevant field of Transport and logistics management or any other relevant degree with Transport and logistics management as a subject which is recognized by the U.G.C.
2. Having obtained a certificate of proficiency in the field of Transport which is not below than the National Vocational Qualification Level 7, issued by a Technical/ Vocational training institute accepted by the Tertiary and Vocational Education Commission.
3. Having obtained a certificate of proficiency in the field of Transport which is not below than the National Vocational Qualification Level 6, issued by a technical /vocational training institute accepted by the Tertiary and Vocational Education Commission

AND

At least five (05) years post qualifying experience in a relevant field in a Corporation, Board or a Reputed Statutory Institution

4. Having obtained a certificate of proficiency in the field of Transport which is not below than the National Vocational Qualification Level 5, issued by a technical/ vocational training institute accepted by the Tertiary and Vocational Education Commission.

AND

At least ten (10) years post qualifying experience in a relevant field in a corporation, Board or a Reputed Statutory Institution.

Age

Should not be less than 22 years and not more than 45 years of age

Salary Scale

Rs. 42,600 - 10 x 755 - 18 x 1,135 - 70,580

Contribution of EPF & ETF
