

INVITATION FOR BID 2021/01

MINISTRY OF LOCAL GOVERNMENT, NORTHERN PROVINCE

1. The **Chairman, Provincial Ministry Procurement Committee**, on behalf of the Ministry of Local Government, Northern Province invites sealed bids from eligible and qualified bidders for the Construction work described in the table below.
2. Bidding will be conducted through **National Competitive Bidding Procedure (NCB)**.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered with the Construction Industry Development Authority (CIDA) in the field of building construction for grade mentioned in the table below.
4. Qualifications requirements are indicated in section 4 of the Bidding document. Additional details are provided in the **Bidding Data and Contract Data** (Section 5).
5. Interested bidders may obtain further information from **address given below in 6**, and inspect the bidding documents at the same place on any working days from 9.00 A.M to 4.00 P.M.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the **Ministry of Local Government, Northern Province, A9 Road, Kaithady. (T.P: 021 205 7114, Fax: 021 205 7120) from 9.00 A.M to 3.00 P.M during the period mentioned in the table upon payment of non-refundable fees as mentioned in the table.** The method of payment should be by cash.

Bids (Original, Duplicate) shall be delivered or sent by registered post to the **Chairman, Provincial Ministry Procurement Committee, Ministry of Local Government, Northern Province, A9 Road, Kaithady** on or before **10.30 AM on the date mentioned in the table.** Bid number must be written on the left-hand upper corner of envelope. Late Bids will be rejected. Bids will be opened soon after closing in the presence of the Bidder's representatives who choose to attend.
8. Pre-Bid Conference will be held at **Ministry of Local Government, Northern Province, A9 Road, Kaithady** commencing at **10.30A.M on the date mentioned in the table.**
