**Northern Province Health Service (Amendment) Statute No. 10/2016**

**A STATUTE TO AMEND THE HEALTH SERVICE STATUTE OF  
NORTHERN PROVINCE, No. 01 OF 2015**

BE it enacted by the Northern Province Provincial Council of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Statute may be cited as the Finance (Amendment) Statute of Northern Province, No. 10 of 2016 and it shall come into operation on such date as the Governor of the Northern Province may give his Assent thereto. Short title and date of operation.
2. Section 8 of the Health Service Statute of the Northern Province No 01 of 2015 is hereby deleted, and the following new subsection is inserted. Amendment of section 8 of the principal enactment.  
“The Provincial Director shall in the exercise, discharge and performance of the powers, duties and functions by this Statute in matters relating to public health, act in consultation with the Head of Local Authority Commissioner/ Secretary within its limits and the Head of Local Authority Commissioner/Secretary shall assist and furnish the required information to the Provincial Director”
3. In the event of any inconsistency between the Tamil and Sinhala or English texts of this Statute, the Tamil texts shall prevail. Tamil texts to prevail in the case of inconsistency.
