

INVITATION FOR BID - 2021/06

PROVINCIAL DEPARTMENT OF HEALTH SERVICES, NORTHERN PROVINCE

1. The **Chairman, Department Procurement Committee**, on behalf of the **Department of Health Services, Northern Province** invites sealed bids from eligible and qualified bidders for the Construction work described in the table below.
2. Bidding will be conducted through **National Competitive Bidding Procedure**.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered with the Construction Industry Development Authority (CIDA) in the field of building construction for grade mentioned in the table below.
4. Qualifications requirements are indicated in Bidding Data (Section 4) & Additional details are provided in the **Bidding Data & Contract Data** (Section 5).
5. Interested bidders may obtain further information from **address given below in 6**, and inspect the bidding documents at the same place on any working days from 9.00 A.M to 4.00 P.M.

The method of payment should be by cash.

Bids (Original, Duplicate) shall be delivered or sent by registered post to the **Chairman, Department Procurement Committee, Provincial Department of Health Services, Northern Province, Health Village, Pannai, Jaffna at or before 10.30 A.M on the date mentioned in the table below**. Bid number must be written on the left-hand upper corner of envelope. Late Bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
